

CHAPTER VII

TRAFFIC

ARTICLE I ON-STREET TRAFFIC REGULATIONS

7-1 DEFINITIONS.

7-1.1 Words and Phrases.

Whenever any words and phrases are used in this chapter, the meaning respectively ascribed to them in Subtitle I of Title 39 of the New Jersey Statutes Annotated shall be deemed to apply to such words and phrases used herein. (Ord. 1-16-79 § 86-1)

7-1.2 Official Time Standard.

Whenever certain hours are named in this chapter, they shall mean either Eastern Standard Time or Eastern Daylight Savings Time as may be in current used in the Township.

7-2 AUTHORIZATION FOR THE CLOSING OF ANY STREET.

- a. The Mayor or, in his absence, disability or inability to act, the Chief of Police is hereby authorized to provide by regulation for the closing of any street or portion thereof to motor vehicle traffic on any day or days during specified hours on any day or days whenever he finds that such closing is necessary for the preservation of the public safety, health or welfare.
- b. Any regulations promulgated by the Mayor and in accordance with paragraph a. above, shall provide for the posting of proper warning signs of such closing on any street or portion thereof during the time the same is closed in pursuance thereof.
- c. Any violation of this regulation promulgated thereunder shall be punished by a fine not to exceed fifty (\$50.00) dollars.
- d. Any regulation adopted that mandates the closing of any street for a period greater than forty-eight (48) consecutive hours shall not become effective unless and until it has been submitted to and approved the Commissioner of the Department of Transportation.

7-3 PENALTIES.

Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violation of Article I of this chapter or any supplement thereto shall be liable to a penalty stated in Chapter I, Section 1-5 of the Rockaway Township Code.

7-4 EFFECT OF CHAPTER.

If any part or parts of this chapter are, for any reason, held to be invalid, such decision shall not affect the validity of the remaining portions of this chapter.

7-5 REPEAL.

All former traffic ordinances of the Township of Rockaway are hereby repealed, and all ordinances or parts of ordinances in conflict with or inconsistent with the provisions of this chapter are hereby repealed, except that this repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance hereby repealed prior to the taking effect of this chapter.

7-6 PARKING.

7-6.1 Regulations Not Exclusive.

The provisions of this chapter imposing a time limit on parking shall not relieve any person of the duty to observe other more restrictive provisions prohibiting or limiting the stopping, standing or parking of vehicles as set forth in N.J.S.A. 39:4-138, any other New Jersey Statute or as hereinafter provided.

7-6.2 Parking Prohibited During State of Emergency.

- a. Upon the declaration of an emergency, there shall be no parking upon street or sections of streets where temporary EMERGENCY NO PARKING signs are displayed. The Chief of Police or, in his absence, the ranking police officer is authorized to declare an emergency and to direct the posting of EMERGENCY NO PARKING signs when weather conditions, accidents, road construction, fire or public celebrations dictate or require avoidance of hazards or other conditions which interfere with the free flow of traffic. Notification that EMERGENCY NO PARKING signs are being or will be posted shall be given to the operator or owner of any vehicle which has been parked prior to the posting of the signs.

- b. The effectiveness of this subsection is contingent upon the signs being erected as required by law.

7-6.3 Temporary Parking Prohibition for Snow Plowing and Removal.

- a. Whenever snow has fallen and the accumulation is such that it covers the streets or highways, an emergency shall exist and no vehicle shall be parked on the streets or highways or portions thereof indicated.

The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.

- b. Any unoccupied vehicle parked or standing in violation shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any police officer may provide for the removal of the vehicle. The owner shall pay the reasonable costs of the removal and storage which may result from the removal before regaining possession of the vehicle.

Parking is prohibited at all times on/along both sides of Split Rock Road for its entire length including any cleared areas adjacent to Split Rock Road, excluding in the designated parking lot on Split Rock Road.

7-6.11 Overnight Parking of Commercial Vehicles, Taxis and Limousines.

No commercially registered vehicle, or any vehicle registered as a taxi or limousine shall park on any street, overnight, within the Township of Rockaway between the hours of 10:00 p.m. and 6:00 a.m. on any day. (Ord. No O-14-26)

7-7 VEHICLES IN EXCESS OF DESIGNATED WEIGHT.

7-7.1 Parking of Trucks Weighing in Excess of Eight Thousand (8,000) Pounds Prohibited.

No person shall park a truck, tractor, trailer, semi-trailer or omnibus having registered gross weights in excess of eight thousand (8,000) pounds upon any street between the hours specified. (Ord. #1-16-79 § 86-9)

7-7.2 Routes for Trucks Over Four (4) Tons.

Pursuant to N.J.S.A. 40:67-16.1, the streets or parts of streets as described are hereby designated as route for Vehicles Over Four (4) Tons. All trucks having a total combined registered gross weight of vehicle plus load in excess of four (4) tons shall be excluded from all streets, except from those streets listed which form a part of the system of truck routes. Vehicles will be permitted on all streets for the purpose of the pick-up and delivery of materials.

7-7.3 Vehicles Over Four (4) Tons Excluded From Certain Streets.

Vehicles weighing over four (4) tons are hereby excluded from the streets or parts of streets designated below, except for local traffic or the pick-up and delivery of materials on such streets. For the purpose of this subsection, the weight of a vehicle shall be determined by the combined total weight of the power unit and the towed unit or units, including the loads on them. Any person, firm or corporation who violates any of the provisions of this section shall, upon conviction, be subject to a minimum penalty of one hundred (\$100.00) dollars. Each and every violation of this section shall be construed as a separate and distinct violation hereof. The Police Department is specifically designated as the enforcement officers.
