**RESOLUTION AMENDING RESOLUTION R-13-60 ESTABLISHING FEES FOR
COPIES**

WHEREAS, in accordance with Ordinance O-13-01, adopted on February 26, 2013, Miscellaneous Fees, Fees for Copies were established for the year 2013 and the established fees would remain until amended by Resolution adopted by the Governing Body;

BE IT RESOLVED, in accordance with Ordinance O-13-21, Miscellaneous Fees, Fees for Copies will be established as follows:

1. Fee for Single Copy of Volume I, of the Revised General Ordinances of the Township of Rockaway is One Hundred Seventy-Eight (\$178.00) Dollars, without a binder. If a binder is requested, an additional charge of \$69.50 will be charged.
2. Fee for Single Copy of Volume II, Land Use and Development Regulations of the Township of Rockaway is One Hundred Seventy-Eight (\$178.00) Dollars, without a binder. If a binder is requested, an additional charge of \$69.50 will be charged.
3. The fee for a copy of the Rockaway Township Street Map, 24 inches by 36 inches is \$2.02.
4. The fee for a copy of any page of the Rockaway Township Zoning Map, 24 inches by 36 inches is \$2.02.
5. The fee for a copy of any page of the Rockaway Township Tax Map, 24 inches by 36 inches is \$2.02.
6. The fee for a duplicate tax bill is three (\$3.00) Dollars for the first duplicate copy, provided the requestor is a mortgagee, servicing organization, or property tax processing organization.
7. The fee for a single copy of the Rockaway Township Master Plan is \$0.05 cents per 8 ½ x 11 page and \$0.07 cents per legal size or larger.
8. The fee for large format copies is \$1.01 per linear foot by thirty-six inches (36") wide.
9. Fees for copies are \$0.05 cents per letter size page or smaller or specifically set forth in N.J.S.A. 47:1A-5.b.
10. Fees for copies are \$0.07 per legal size page or larger, unless the Township can demonstrate that its actual costs for duplication of a government record exceed the foregoing rate then the Township shall charge the actual charge of duplicating the record, or specifically set forth in N.J.S.A. 47:1A-5.b.

11. Fees for electronic media provided via USB:


- a. 4GB USB is \$5.09
- b. 8GB USB is \$6.09
- c. 16GB USB is \$6.59
- d. 32GB USB is \$7.45

12. A special service charge, in addition to the actual cost of duplicating records, shall be imposed if the record cannot be reproduced using ordinary equipment or complying with the request involves an extraordinary expenditure of time and effort. Said special service charge shall be reasonable and based on actual direct cost as provided for in N.J.S.A. 47:1A-5.c.

13. The fee for a certified copy of a birth certificate, death certificate, marriage certificate, civil union certificate or affidavit of domestic partnership is Ten (\$10.00) Dollars per copy. The fee for vital statistic information only is Five (\$5.00) Dollars. The fee for a certified copy of a corrected birth certificate, death certificate, marriage certificate, civil union certificate or affidavit of domestic partnership is Ten (\$10.00) Dollars per copy.

14. The fee for a single audio or video disc shall be \$1.99 per disc.
